## TIPS AND TRAPS FOR OBTAINING, USING AND PROTECTING SURVEILLANCE

Since the introduction of the *Personal Injuries Proceedings Act 2002* there has been much uncertainty with respect to how the disclosure provisions within that Act affect surveillance footage and reports.
