SIR NINIAN STEPHEN	Sir Ninian Stephen, past Justice of the High Court of Australia and past Australian Governor- General, made significant contributions to the development of insurance law. His judgment in the matter of <i>The Distillers Company Biochemical (Australia) Pty Ltd v Ajax Insurance Company Ltd</i> [1974] HCA 3; (1974) 130 CLR 1, is still regularly referred to more than 40 years later as the starting point for any discussion in relation to the post-contractual duty of utmost good faith and aggregation clauses. The post-contractual duty of utmost good faith connection is particularly apt as 2016 is the 250 th anniversary of the seminal utmost good faith case of <i>Carter v Boehm</i> .
